#### KEEP OUT OF REACH OF CHILDREN.

## SECTION 7 – HEALTH AND FIRST AID

#### PRIMARY ROUTES OF ENTRY & EFFECTS OF OVER EXPOSURE:

**Eyes:** May cause irritation, redness and tearing.

- Skin: Frequent or prolonged contact may cause irritation. May aggravate existing skin conditions.
- Inhalation: Inhalation of mist can cause irritation of nasal and respiratory passages. Frequent or prolonged exposure may cause irritation to the upper respiratory tract, coughing, dizziness, nausea and headache.
