	6. ACCIDENTAL RELEASE MEASURES
Emergency procedure:	Flammable/combustible material. ELIMINATE all ignition sources (no smoking, flares, sparks, or flames in immediate area). Stay upwind; keep out of low areas. Immediately turn off or isolate any source of ignition. Keep unnecessary people away; isolate hazard area and deny entry. Do not touch or walk through spilled material. Clean up immediately. 	7. HANDLING AND STORAGE


