6. STORAGE AND HANDLING INFORMATION

7. HEALTH HAZARDS AND FIRST AID

Effects of Overexposure:

SKIN: Skin irritant. Will cause defatting of skin. Effects are reversible.

EYES: Eye irritant. Will cause redness and burning sensation.

INHALATION: Effects of overexposure include irritation of respiratory tract, headache, dizziness, nausea, and loss of coordination. Extreme overexposure may result in unconsciousness and possibly death.

INGESTION: Aspiration hazard if swallowed.

Prolonged overexposure to solvents in Section 2 may cause adverse effects to the liver, urinary, cardiovascular and reproductive systems. Repeated and prolonged overexposure to solvents may lead to permanent brain damage and nervous system damage.

First Aid Procedures:
